

- (a) **I GIVE** my shares and interest in Worldmark South Pacific Club by Windham, PO Box 7493, Gold Coast 9726 to my daughter **LOUISE ROSLYN SHERLOCK**.
- (b) **I GIVE** the remainder of my residuary estate to such of my children **TREVOR NOEL PATTEN, GARRY JOHN PATTEN, LOUISE ROSLYN SHERLOCK** and **CHERYL ANNE KNOWLES** who survive me and if more than one equally.
- (c) **IF** any child of mine dies before me leaving a child or children surviving me then that child or those children (being my grandchildren) who attain the age of Twenty one (21) years will take and if more than one equally the share in my estate that my child so dying would otherwise have taken.

TRUSTEE POWERS

7. **I DECLARE** that in addition to all other powers conferred by law my Trustees shall have the following powers:

- (a) To **retain** as an authorised investment of my estate such part or parts thereof as my Trustees may think proper.
- (b) To invest trust moneys for the time being in their hands and available for investment under the terms of this will in accordance with Part 1 of the Trustee Act 1958
- (c) To apply the whole or any part of the income or capital of the vested presumptive or contingent share of any beneficiary as my Trustees may think fit **for or towards the advancement maintenance support education benefit or use** of that beneficiary and (without limiting the advancement and maintenance powers hereby given) with power to pay the same (without seeing to its application) to any person who in the opinion of my Trustees is the **guardian** or has the care and custody of that beneficiary or who is apparently willing and able to so use that income or capital.
- (d) To **appropriate** any part or parts of my estate (including, without derogating from the generality of the forgoing, income or capital having or in respect of
